



SERVICE PARK - Covered market

Covered market

All teams must be placed in the covered market, at the discretion of the Organising Committee.

If you wish to reserve a place in the covered market, you must send a written request to the organisation to info@racspa.be. Without a reservation, teams will be placed at the discretion of the organisation.

The request must be sent by 29 January 2024 at the latest. After this date, the request cannot be considered.

The request must include the following elements

- Name of the team
- Details of the team manager
- Teams concerned
- Plan of the desired location (with dimensions)

The maximum authorised space is 50 m² per participating car. Beyond that, and depending on availability, additional m² will be invoiced at 10 € / m².

Competitors must strictly comply with the plan drawn up by the Organising Committee.

Security

Electricity

There are no electrical terminals.

All electrical installations must comply with the General Regulations for Electrical Installations.

The RAC Spa and the City of Bastogne will not be held responsible for any accidents that may occur as a result of an illegal or non-compliant connection and cannot be held responsible in case of power cuts

Ballast

All temporary structures must be securely fastened or ballasted with a minimum of 5Kg per m².

Gas

Gas installations are strongly discouraged. Any gas installations that may be present must comply fully with current legislation.

Strict controls will be carried out by the fire brigade. The Organising Committee reserves the right to dismantle any installation that does not scrupulously respect all safety regulations.

Accessibility

The service park is accessible from Thursday 1st February at 09:00.

All installed structures must be removed and the waste removed by Sunday 4th February at 23:59.

Only one vehicle identified by the sticker "SERVICE" will be allowed in the service park. Any vehicle not authorised in the service park will be removed.

Miscellaneous

In the service park, it is compulsory to use the bins and containers provided for this purpose by the organisation. It is forbidden to throw away tyres, pieces of glass, brake pads, oil

A fire extinguisher of at least 6kg is compulsory for each competitor's vehicle on each assistance site. It must be visible and its presence may be checked during the event.

Any commercial operation and/or organisation of a reception area is subject to the authorisation of the Organising Committee.

Any damage caused to the service park will be entirely at the expense of the competitor in question.

The access is subject to the respect of the covid protocol in force which will be communicated later.
